GENERAL ORDER RE: IMPLEMENTATION OF EMERGENCY RELIEF AUTHORIZED
PURSUANT TO GOVERNMENT CODE SECTION 68115 BY CHAIR OF JUDICIAL COUNCIL

Exercising the authority granted under Government Code section 68115, and to implement the December 24, 2020 Order of Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council of California, issued in response to the December 24, 2020 amended request for an emergency order made by the Superior Court of Butte County, this Court does adopt the findings and orders of the Chief Justice and, incorporating the same herein, does HEREBY FIND and ORDER:

1. That the time period provided in section 825 of the Penal Code within which a defendant charged with a felony offense must be taken before a magistrate is extended from 48 hours to not more than 7 days, applicable only to cases in which the statutory deadline otherwise would expire from December 23, 2020, to December 28, 2020, inclusive.

NOW, THEREFORE, IT IS ORDERED, the proceedings set before Judge Jesus A. Rodriguez on Wednesday, December 23, 2020 at BCCH, for the cases referenced herein, are continued, as indicated below, with defendants held subject to bail in accordance with the Bail Schedule unless otherwise indicated, and will be heard at the North County Courthouse located at 1775 Concord Avenue, Chico, CA, via video conference:
